फ्रिवेवरील अपघातात 🕫 वर्षांच्या तरुणाचा मृत्यू

फ्रि वेवरील अपघाताच्या एका घटनेत २० वर्षांच्या तरुणाचा मृत्यू झाल्याची घटना काल पहाटे वडाळा परिसरात घडली. अपघातात मृत्यू झालेल्या तरुणाची ओळख पटली असून त्याचे नाव आदित्यकुमार तिवारी असल्याचे पोलिसांनी सांगितले.

हा अपघात काल पहाटे पावणेचार वाजता वडाळा येथील इस्टर्न फ्रिवेवरील साऊथ बाँडवरील बेस्ट इलेक्ट्रीकल पोल क्रमांक २७३ ते २७५ दरम्यान झाला.

फ्रिवे एक्सप्रेसवर दुचाकी वाहनांना बंदी आहे. तरीही काही दुचाकी वाहनचालक पोलिसांना चकवून फ्रिवेवर भरवेगात जातात.

काल पहाटे पावणेचार वाजता आदित्यकुमार हा फ्रिवेवरुन जाण्यास बंदी असताना तेथून भरवेगात त्याच्या मोटारसायकलवरुन जात होता. यावेळी बेस्ट इलेक्ट्रीकल पोलजवळ त्याचे मोटारसायकलवरील नियंत्रण सुटले आणि त्याने तेथील डिव्हाडरला धडक दिली. त्यात तो गंभीररीत्या जखमी झाला होता.

अपघाताची माहिती मिळताच वडाळा पोलिसांनी घटनास्थळी धाव घेतली होती. जखमी झालेल्या आदित्यकुमारला तातडीने केईएम रुग्णालयात दाखल करण्यात आले होते. मात्र तिथे त्याला डॉक्टरांनी तपासून मृत घोषित केले. या अपघाताला आदित्यकुमार हाच जबाबदार असल्याने त्याच्याविरुद्ध पोलिसांनी गुन्हा नोंदविला होता.
